IV. Bachelor of Business Administration in Technology Management*.

**/These programmes are fully self-financed. In order to attract bright students, IUT shall provide special Partial Scholarship in one of these programmes to one (01) overall best international student admitted on self-finance on condition that he/she maintains CGPA of 3.75 out of 4.0 or above in subsequent years; otherwise his/her scholarship will be forfeited and he/she will need to pay full fees as specified in the payment schedule of self-finance students.]*

Depending on the availability of resources and payment of mandatory contributions by the Member States, and until the Authority allows, the University will award stipend to eligible students as per rule.

The University would request the esteemed Embassy to kindly forward nominations of their candidates along with their applications in the attached prescribed forms duly filled in and with attested copies of all Academic Certificates, Mark-Sheets and Testimonials as well as Medical Fitness Certificate as explained in the offer letter so as to reach this University by **31 August, 2019**. **Applicants having contagious and communicable diseases are not eligible for admission.**

One (01) set of documents, which include the Announcement for Admission for Academic Year 2019-2020 containing details of entry requirements, financing, academic calendar, etc., Application Forms and the Guidelines for selection of candidates for nomination to various regular programmes are enclosed. **These documents may be duplicated by photocopying, if necessary.**

It would be highly appreciated if the Nominating Authorities announce this offer in their local media houses as news item in order to inform potential applicants to apply for these Programmes in time for early nomination. A draft advertisement on the matter is enclosed herewith for kind perusal and necessary action. Nominations should reach before **31 August, 2019** to allow the University to scrutinize, select and inform the successful candidates so that they can prepare for their visa, Air-ticket etc., in due time. Please be informed that **the medium of Instructions and Examinations of IUT is English.** As such all applicants are required to have good knowledge of English.

The University avails itself of this opportunity to renew to the esteemed Embassy the assurances of its highest consideration.
